## Feast of the Baptism of the Lord

Isaiah	40:1-5,9-11
Titus	2:11-14;3:4-7
Luke	3:15-16,21-22

To make a discovery about someone we know or to gain a fresh insight into ourselves is a threshold, a turning point. The deeper our new knowledge, the most we are changed. Once we have passed that threshold, we are never quite the same again. What is happening in the readings of the recent Sundays and feasts is a progression in the story of the manifestation of Jesus as the Chosen One of God. John the Baptist is the one who is preparing the way for Jesus. Jesus has come upon a threshold or turning point in his life when he is baptized by John the Baptist. He is responding to His inner call. He is making a public statement about His life and His mission. In our life as a Christian, our individual call to holiness and mission is affirmed and celebrated in many ways. We recommit ourselves to our call each time we put our hand in the Baptismal font and make the sign of the cross that we are renewing our pledge of Baptism. Each time we receive the Eucharist, we are recommitting ourselves to our mission to serve the Lord.
