Here are the best ways to stay in contact:

- 1) Have you downloaded My Parish App? Go to myparishapp.com/download for links to download this app. You can also search for the app in the App Store or on Google Play. When you download the app, search for St. Thomas by entering the zip code 61616, or by turning on location services. Make sure you enable notifications. We will send out an alert when we have important information to communicate about upcoming events, especially once public Masses resume.
- 2) Are you on our email list? We send out a weekly email with a link to the bulletin and a summary of important events every Friday morning. If you don't receive this email, please contact the parish office and we will be happy to add you to our notification list.
- Bookmark the parish website: <a href="mailto:stthomaspeoria.org">stthomaspeoria.org</a>. We will post important notices on the homepage of the site.

Some services will continue, such as the parish office and the food pantry. Other events will be delayed, including the Fish Fry. Other parish groups will meet on a "to be determined" basis. Contact your group's organizer for information about when you will meet. The Msgr. Rank Mass for the faithful departed will take place on March 25, though it may be private if the restrictions are not lifted by this date.
