Holy Week and Easter rank as the most important moments we celebrate as believers of Jesus Christ. Beginning with Palm Sunday and continuing through Easter Sunday, these events will be streamed live through the diocesan website: www.cdop.org. It won't be the same as being together, in person; but enables us to be united in ways that the current times make possible.

In these difficult times when we each have to carry our own personal crosses, we do so in the hope of Easter glory. I ask your prayers for me and for your priests. Please know that I am holding you close to my heart and I am praying for you daily.

Today is Palm Sunday and the beginning of Holy Week. This is the day when we celebrate the triumphant entrance of Our Lord into Jerusalem. The crowds of Jerusalem were filled with such excitement that they greeted Jesus with joy, cutting down palm branches and spreading them along the road. This is also the day when we recall the crowds turning on Jesus and calling for his crucifixion as we proclaim the Lord's Passion.

While it is not possible to hold Mass publicly, please know that we are united with you as we pray together on this day. Your prayers at home are joined with our prayers as we offer Mass for you privately.

We will bless palms on Palm Sunday, and we will make palms available for you and your families. You will be able to pick them up from the church when it is safe to do so. Many people cherish the spiritual practice of placing the palm in your home as an expression of faith. We want to continue to provide for this.

I will post a reflection for Palm Sunday on our parish blog. You are welcome to listen to this reflection and the other messages that are also posted on our blog. Reflections will also be posted for the days of the Triduum, from Holy Thursday to Easter Sunday.
